1976 till 1985 probation officer for the organisation "NEUSTART" (former association of probation service and socialwork). In my occupational history I am since 1981 a state official. In 1985 I started as Co -Initiator and member of the Project-team the „victim-offender mediation" (conflict resolution in penal matters) for juveniles in Vienna. From 1993 to 1996 I was in charge of the Viennese office of victim-offender mediation for juveniles. Then the project was enlarged for adults where I also took part. Since 1996 I manage a team of 16 mediators for juvenile and adult cases in Vienna. Up to now I have mediated already 3000 victim-offender cases, mostly of them successfully. In the management-group of the „victim-offender mediation" located in Vienna I am responsible for the management and for the cooperation with the legal authorities.
